#### Clean-up Costs

SINCE 2002

- ITAD, recyclers, OEMs, non-profits and government agencies-paid \$11 Million + for Clean Up Costs of defunct CRT processor in OH; AZ estimated at \$15 million
- TJ Maxx-\$2.05 million for Improper Disposal of items including electronics and batteries from 2016-2021. Paid \$2.77 million for same thing in 2014!
- Old Dominion Freight-\$1.36 million in 2022
- Walgreens, BB&B, Ross-over \$8.0 million in 2020





#### ESG-New Buzzword for Sustainability Reporting, or Does It Go Further?

- R2 and e-Stewards Require Tracking of Downstream Vendors/Processors
- Reducing Carbon Footprint, Using Less Resources, Less Mining, Saving on Energy
- Reuse Internally, Charitable Donations
- Avoid Landfill





## US Recyclers Process More Than 5 Million Tons Annually

1 million cellphones recycled yields

- ✓ 33 pounds of Palladium
- ✓ 75 pounds of Gold
- ✓ 772 pounds of Silver
- ✓ 35,000 pounds + of Copper

1 million laptops recycled = Energy savings equivalent to electricity used by almost 3700 homes annually. ✓ Reuse
✓ Refurbish
✓ Recovery
✓ Recycle

Fun Fact: 2200 pounds of personal computers (PCs) contain more gold than that recovered from 17 tons of gold ore

- 2020-2022: Morgan Stanley fined \$60 million by Treasury Department; Legal settlement \$68.2 million; fined \$35 million by SEC
- 2022: T-Mobile \$350 million
- 2023: DNA Diagnostic Center \$400,000
