

What is our definition of IT Asset Disposal/Disposition?


IT asset disposition, or ITAD for short, is the practice of how and where to dispose of IT hardware.

IT asset disposition (ITAD) is an industry term and practice built around reusing, recycling, repurposing, repairing or disposing of unwanted IT equipment

ITAD is the practice of properly decommissioning and disposing of hardware and electronic devices.



Who do we entrust?

Gartner divides ITAD services into three high-level categories:

- 1) Core disposition services: A menu of services that are core to all end-to-end ITAD processes and that must be evaluated on a make-or-buy decision scale
- 2) Secondary hardware services: The acquisition of used or secondary equipment from ITAD providers and their partners 3)
- 3) Ancillary life cycle services: Services offered by full-service ITAD providers in addition to most of the core disposition and hardware services

- Legal

External Resources

- Brokers/Dealers
- Value Added Resellers/Distributors
- ITAD Processors
- Recyclers

How do we go about setting up the ITAD Program?

Understand the primary drivers and desired results before you take the first step.

How do I go about setting up the ITAD Program?

Primary Business Drivers: (Examples of but not limited to)

- Operational Program versus Project Based
- Technical End of Sale/Support
- Financial Funded Effort; Leased Assets; Revenue Stream Impact
- Risk/Governance Protecting Intellectual Property, Legal Compliance
- Environmental/Sustainability Impacting the Planet



How do I go about setting up the ITAD Program?

Primary Service Drivers:

- DATA Where will the data be generated, aggregated, reported and stored?
- Logistics Management How are we aggregating the assets?
- Freight How are we moving the assets from point A to B etc?
- Re-Usage Internal, Secondary markets, Donation or Recyclables (whole units or parts)
- Security Removal of Company Intellectual Property and or Identifiers



When should I focus on the ITAD efforts?

Get started "NOW"

- 2. Impact the Financials
- 3. Champion Sustainability
